Formerly known as the Sindh Regional Planning Organization (SRPO), the Research and Training Wing was formed in 2006 after SRPO was repealed in 2005. The overarching idea of its formation was to act as an in-house capacity development body for the Planning and Development Department (Govt. of Sindh) and ultimately cater to the capacity needs of all the government departments. Unfortunately, the Wing remained dormant till 2017, after which the P&DD initiated its revitalization and restructuring with support from the European Union's Public Financial Management- Support for Pakistan Program team.

Under the leadership of Chairman P&D Board and guidance of the Secretary Planning and Chief Economist, the process of revitalization and restructuring began in 2017. The reorientation towards a technical organizations' setup entailed hiring sectoral experts from open market to develop the Wing and facilitate its evolution as an intellectual institute. A state-of-the-art office was also established to cater to the modern needs of the research personnel. With the completion of hiring process in early 2018, the Wing is now equipped with the human capital to progress as a capacity development body for P&DD.

Under the leadership of its Director-General, the Wing has been able to impart trainings and conduct actionable research to inform strategic planning of the Department. The Wing has quickly been able to develop a work-plan with P&D Board's approval and has already delved into operationalizing the objectives defined in its work-plan. During FY 2019-20, R&TW has been able to impart both in-house and institutional trainings on a broad spectrum of topics including data analysis, qualitative research survey design & evaluation methods, evidence-based program design, public sector negotiations & conflict resolution and others. Partner academic institutions like SZABIST, IBA-Karachi and Center for Economic Research in Pakistan tailored their trainings to the needs of P&DD officials.

Research & Training Wing was also pro-active in providing strategic input to the Planning & Development Department on priority areas that included ease of doing business reforms, digitalization of P&DD, situational analysis of quarantine and isolation accommodation facilities in Sindh, assessing the provincial COVID-19 impact & mitigation strategies and critical analysis of Annual Plan Coordination Committee.

Director-General Research and Training Wing was the focal point from P&DD on the World Bank's research initiative to maximize the impact of Public-Private Partnerships in health sector. DG R&T Wing facilitated the World Bank team in conceptualizing the research study to unpack the public-private partnership arrangements to draw broad-based policy lessons for informing future PPP contracts development and management.

R&TW has also developed a series of in-house research reports that focus on the thematic areas of Ease of Doing Business, Food Security, Macro-Economic & Socio-Economic Impact Assessment of COVID-19, Development Portfolio Analysis of Sindh & Karachi, and Critical Analysis of the 'Modern Economy of Sindh'.

The ultimate aim of the Wing is to be a source of practical knowledge transmission by imparting research and training through long-term partnerships with academia, development partners and other stakeholders. The Wing will keep evolving and developing with support from the Government leadership that initiated its revitalization.





From the 1976 – 2020

History

1976 - 2005

The Research and Training Wing was formerly known as Sindh Regional Planning Organization and was formed under SRPO Act of 1976. SRPO was responsible for developing district level plans for P&DD and inform the overall planning for the province. The structure of organization was different from what it is now, and the overall functions of SRPO were not specific and thus not focused. The SRPO was repealed in 2005 and Research and Training Wing was formed in 2006. The Wing was envisioned as the knowledge hub for P&DD for evidence-based planning and policy formulation using highquality research.

Revitalization

2006 - 2017

Despite its formation and organization in 2006, the Wing still lacked focus on the training and research aspect, and thus the department was virtually dormant. Therefore, in 2017, the Planning and **Development Department** of the Government of Sindh initiated the process of revitalization with technical support from European Union Public Financial Management Support Program for Pakistan (EU PFM-SPP). The primary aim was to enhance public sector delivery, to enhance the capacity of human resource and to meet the modern-day development challenges by adopting modern techniques and tools of planning and development for sustainable development of Sindh.

Reforms

2018 - 2020

The reforms undertaken for revitalization, restructuring and strengthening of the Wing were initiated by the senior leadership of GoS and P&DD, especially Hon. Chief Minister, Chairman P&D Board, Secretary Planning and Chief Economist (P&DD). Since the revitalization of the department in 2017. there has been a change in organizational structure and now the Wing works in a technical setup. Since the re-revised project proposal has been approved, a technical team of 10 members of the core staff has been made.

Training Needs Assessment

The Revitalized and Restructured Research and Training Wing, P&DD, GoS, conducted a comprehensive thematic based Training Needs Assessment of the Planning and Development Department to assess the skills gap in functional competencies and specific training needs of the employees to design, facilitate and conduct customized in-house and institutional trainings. Training Needs Assessment was conducted through Questionnaires and targeted staff members of BPS 5 and above. R&T Wing's aim was to reach as many employees as possible and that why detailed and comprehensive is a questionnaire was designed and circulated to all sections/projects/wings of P&D. After the data received through completed TNA questionnaires (332 employees); the analysis was done to understand training preferences and areas identified by the employees.

Qualitative Research Methodology & Data Analysis Using NVIVO at IoBM

The Wing partnered with Institute of Business Management for an institutional training on Qualitative Research for its research staff.

Being the primary Research Wing of P&DD, it is essential to equip its technical staff in both qualitative & quantitative research and analysis. Research Associates and Monitoring, Evaluation & Learning Officer from R&T Wing participated in the two-day training on Qualitative Research Methodology & Data Analysis Using NVIVO software at the Institute of Business Management (IOBM).

Participants learned how to organize, classify and sort the different types of data. They further learned how to transcribe audio/video recordings using NVivo transcription tools and how to identify themes and apply codes (coding types & tree nodes).

The workshop also focused on inculcating knowledge regarding exploration of results in different forms e.g., tag clouds, tree maps, cluster maps, coded matrixes, graphs, charts etc. and how to interpret and report the qualitative findings.

Basic IT Skills in Collaboration with ZABTECH

Bureau of Statistics (P&DD) requested R&T Wing to facilitate in organizing and imparting typing & basic IT skills training to its staff members of BPS 1-5 who were eligible for promotion and as per recruitment rules were supposed to be have typing and basic IT skills.

In this context, R&T Wing collaborated with ZABTECH. The course was spread over 02 months and started from 2nd September 2019. 14 trainees dedicated 04 days a week i.e. Monday to Thursday and 03 hours per day for this course. The course was taught at 10 different locations, simultaneously across Sindh.

The course's prime objective was to teach all the required tools and features of Microsoft Word, taking participants MS Word efficiency from basic to advance level. Apart from Microsoft Word, participants were also trained on how to improve typing skills with accuracy.

A series of trainings has been organized by RTW to augment the capacity of P&D employees. Therefore, RTW held an inhouse customized training on SPSS for to improve the analytical capacity of P&DD Officers.

The 2-day training was held at the Pakistan Institute of Management (PIM) and the trainer was Mr. Obaid Arshad Khan –Social Sector Advisor from RTW. This training aimed at increasing the capacity of senior P&DD Officials to critically analyze quantitative data using Statistical Package for Social Sciences (SPSS) and to develop analytical skills to interpret and communicate key findings.

The learning objectives included Improved Data Management Skills, Improved Interpretation of Data, Improved Data Analytical Skills, Improved Graphical Presentation of Data, Improved Working Knowledge of Descriptive and Inferential Statistical Analysis using SPSS.

The Chief Economist and Director General – RTW distributed the certificates of participation to all the participants.


Evidence-Based Program Design in Collaboration with J-PAL (MIT), Harvard Kennedy School & Clear Initiative at CERP

Centre for Economic Research in Pakistan held a five-day workshop on Evidence-Based Program Design (EBPD), an annual training programme held by CERP in collaboration with JPAL (MIT), Clear initiative and Evidence for Policy Design (EPoD) at Harvard Kennedy School (HKS) in Lahore from 9-13 December 2019.

The programme taught participants to apply Smart Policy Design and Implementation (SPDI): a six-step framework identified by EPoD that integrates evidence to develop policies. To inculcate the learnings of the modules taught by the leading faculty (namely) Dr. Asim Khawaja, Dr. Kate Vyborny, Dr. Tahir Andrabi, Dr. Ali Hasanain, Dr. Farooq Naseer, Mr. Maroof A. Syed, Ms. Maha Rehman, Mr. Adeel Shafqat, Ms. Nazish Afraz and Mr. Osman ul Haq.

Research and Training Wing collaborated with CERP to ensure participation from the Government of Sindh in CERP's training for the first time. Officials who attended the training from the Government of Sindh included Ms. Iffat Malik (Programme Coordinator-PPRP), Mr. Obaid Arshad Khan (Social Sector Advisor, R&T Wing), Mr. Zulfiqar Keeriyo (Economic Growth Advisor, R&T Wing) and Mr. Shahzeb Ahmed Shaikh (Regional Monitoring & Evaluation Officer, M&E Cell).

Public Sector Negotiations and Conflict Resolutions Held at IBA Karachi

Survey Design and Evaluation Methods

Survey Design and Evaluation Methods

The training was conducted by the Social Sector Advisor (R&T Wing) and was centered on imparting in-depth knowledge of survey design and evaluation methods for Statistical Officers of the Bureau of Statistics (P&DD, GoS) for designing surveys and conducting rigorous evaluations, particularly impact evaluations. The overarching objective of the training was to impart skills to create a credible evidence-base with sound research methodology for informed planning and decisionmaking.

The first day of the training focused on introducing the trainees to survey designs along with sampling methodologies and evaluation methods with interactive exercises. The second day was focused on the trainees learning about experimental, quasiexperimental and non-experimental evaluation designs. Trainees presented the key learnings from the training with real world examples to reflect in-depth understanding of designing surveys and conducting outcome/impact evaluations. It is hoped that the Statistical Officers who received this training can substantially improve their service delivery with improvements in research, evaluation and analytical skills.



Discovering Leadership through Self-Analysis at IBA

Discovering Leadership through Self-Analysis at IBA

Centre of Executive Education (IBA) organized a 02-day training workshop on Discovering Leadership through Self-Analysis.

The workshop focused on leadership behavior, personality and styles. Other important leadership areas, included communication, emotionality, decision making and use of power, were covered to discover the leader within participants. Through analyses-based discussions, suggestions were made to push participants closer to being an effective leader.

Learning outcomes on the training were Utilize emotionality as an effective leadership tool, improve decision-making as a leader practically difficulty decisions, Identify the traits and behaviors of an effective leader, Action learning the relationship between leadership and environment, Understand the leadership context of communication and how it impacts the information flow, Manage relationships between leader and team members, Effective use of power.

Mr. Abdul Kaleem Shaikh, Assistant Chief, PP&H Section attended the subject training and learned valuable lessons with regards to Leadership.



IPC Acute Malnutrition Analysis Workshop by (FAO)

Integrated Food Security Phase Classification Acute Malnutrition Analysis Workshop by (FAO)

Social Sector Advisor, R&T Wing, was nominated by the Planning & Development Department to attend the 7-day 'Integrated Food Security Phase Classification (IPC) Acute Malnutrition Training and Analysis Workshop' that was organized by Food and Agriculture Organization (FAO). The rigorous training focused on utilizing credible evidence (national and international surveys) to conduct a situational and predictive analysis of acute malnutrition in the selected districts of Sindh. The analysis then feeds into the phase classification of districts to determine the current and predicted severity of acute malnutrition in the district along with major contributing factors. Social Sector Advisor successfully completed the training and analysis along with the online test to meet all the requirements for international certification of Acute Malnutrition Level-I Analyst. The official certification was awarded to the Social Sector Advisor by IPC Global Steering Committee and IPC Global Support Unit on 28th November, 2019.



Water Law at NED University

Water Law at NED University

The Panjwani-Hisaar Water Institute (PHWI) is a collaborated effort of NED University, Panjwani Charitable Foundation and Hisaar Foundation. The PHWI aims to stimulate and inculcate innovative water education, research and training that is multidisciplinary in nature and integrates the currently isolated nodes of engineering and social science in Pakistan's water sector. The focus is on harnessing all the linkages between water users, water uses and different stakeholder groups to promote informed policy and actions at all levels.

The institute organized a 05-day training course on "Water Law". The course was attended by five senior officers from Water & Drainage Section, Sindh Water Sector Improvement Project, Directorate of Urban Policy & Strategy Planning, and Monitoring & Evaluation Cell attended this course.

The course was designed for professionals to understand the existing legal environment around water sector (international, national, provincial and local) and implications for water governance, management and conservation in Pakistan.

R&TW aims to play the instrumental role of a conduit between the academia and government to bring together top international and national researchers to engage with policy makers in Sindh and Pakistan for effective solutions to the challenges faced by the province and country.

Our approach is centered on actionable academic research that feeds into planning and policy formulation of the Planning and Development Department. Ultimately, our partnerships and collaborations with both academia and industry would lead to improved service delivery for the population. Capacity development of the public sector is also a core component of our objectives which has both direct and indirect connections with our research approach.

PRIORITY SECTORS



Sindh Development Review (SDR)

Research & Training Wing was tasked with preparing a 'Sindh Development Review' of the Development Investments made by the Government of Sindh in the last five years from a sectoral perspective. Under the guidance of Director-General, the Wing obtained the data from relevant P&DD Sections on the investments incurred and flagship initiatives undertaken in the last five years. The requisite information was collated into a coherent report format that highlighted the five-year development initiatives of the government. The sectors covered in the report included:

-Health

-Education

-Social Protection and Poverty Reduction

-Water Supply, Sewerage and Solid Waste Management


-Agriculture

-Sports, Culture & Tourism

-Transport & Communication

The overarching objective of developing a 'Five-Year Development Report' was to have a consolidated document that systematically presented the development priorities of the Government in the aforementioned prioritized sectors.





Karachi Development Report (KDR)

Similar to the task of 'Sindh Development Review' report, the Wing was given the assignment by the P&D Board to prepare a six-year development report that focused on the development investments directed towards Karachi from FY 2013-14 to FY 2018-19. Following prioritized sectors were focused on for analysis:

-Health

-Education

-Water and Sanitation

-Roads

-Mega Projects

The Wing promptly collected relevant data from P&DD sections to develop a comprehensive report on the Government's development investments on broad-based infrastructure and social sector schemes for Karachi. The report helped in analyzing the quantum of investments made by the Government for urban development in the biggest metropolitan of the country. The completed report was duly presented to the P&D Board.



Collaboration with Cambridge University Scholar to facilitate Research Study on "Zoonotic Diseases in Sindh"

Collaboration with Cambridge University's Gates Scholar to Facilitate Research Study on "Zoonotic Diseases in Sindh"

Miss Dorien Braam, a Ph.D. Scholar from Cambridge University, visited Pakistan during the month of Oct. & November 2019. She was facilitated by R&T Wing in a primary research study focused on Zoonotic Diseases in displaced populations of Sindh. R&T Wing organized several meetings and interviews for Ms. Braam with Stakeholders i.e., NGO representatives, Livestock & Health Officials and Displaced Population for her study.

Mr. Naeem Chandio – Monitoring, Evaluation & Learning Officer - at the Research & Training Wing assisted Ms. Dorien Braam in the field to conduct research. Qualitative interviews were conducted with male & female population of villages in Thatta & Sujawal districts. The objective of this research study was to assess the knowledge, attitude and practice of targeted communities, who own livestock, regarding zoonotic diseases during any disasters in their area.



Charting the Course of Doing Business Reforms in Pakistan with Lessons from Top Global Performers

Ease of Doing Business Report (EoDB)

To expedite the inter-departmental coordination in catalyzing ease of doing business reforms in Sindh, the Chairperson P&D Board tasked the Social Sector Advisor of R&T Wing to facilitate stakeholder meetings to push the Doing Business Reforms Action Plan. On behalf of P&DD, the Social Sector Advisor held several meetings with relevant departments to catalyze the progress on action plan to further improve Pakistan's Ease of Doing Business rankings.

An in-house research report was also prepared by the Social Sector Advisor, based on secondary analysis, to highlight the initiatives undertaken by Pakistan (specifically Sindh) to facilitate ease of doing business by providing a conducive regulatory environment for businesses to flourish. The report also highlighted examples from the top doing business global performers to provide useful insights and lessons for Pakistan to emulate. The report can be found on R&T Wing's website.

Under the guidance of Chief Economist of P&DD, the Wing was tasked with preparing a report on 'Macro- and Socio-Economic Impact Assessment and Development Response Framework for COVID-19 in Sindh'. The Wing collaborated with UNDP's Sindh SDGs Support Unit to prepare the report.

The provincial estimations were computed using the nationallevel estimated sectoral impact by the Sub-Committee of National Coordination Committee tasked with COVID-19 economic analysis. The overarching objective of this report was to assess the estimated impact of COVID-19 on key provincial macro-economic and socio-economic indicators in order to identify prioritized areas of intervention for the Government to guide economic recovery and social protection of the vulnerable segments of population.



Gender Parity in Public Sector Report

Gender Parity in Public Sector Report

Social Sector Advisor prepared a 'Gender Parity Report' using Global Gender Gap Report and Accountant General Sindh Working Employees Data Analysis. Under the notification issued in the Letter No. SORI(SGA&CD)2-1/94, dated 8th March, 2017, the Government of Sindh enhanced the Women Quota from 5% to 15% for recruitment of women under the Sindh Government (attached).

To ascertain the present status of female proportion of the total working employees, the Research and Training Wing has conducted an in-depth gender disaggregated analysis of the working employees to examine the female participation in the GoS workforce through the stratifications of departments, basic pay scales and districts. Research and Training Wing utilized the Global Gender Gap Report of 2018 and Gender-Disaggregated working employees' database of A.G. Sindh to produce a Gender Parity Report for the working employees of the Government of Sindh.

State of Food Security in Pakistan Report

State of Food Security in Pakistan Report

A series of research reports have been prepared by the core research staff of the Research & Training Wing on various socioeconomic thematic areas in context of Sindh. R&T Wing's Research Associate – Mr. Asad Siddiqui prepared an insightful report on 'The State of Food Security in Pakistan' Using Sensitivity Price Index and Time Series Analysis of Agriculture Productivity Data.

The report analyzes food security situation in Pakistan, focusing on Sindh through the lens of accessibility, consumption and stability dimensions. It was observed that almost 47.1% of people living in Sindh were considered to be food insecure. Also, the agriculture productivity of Sindh has decreased significantly for major pulses and vegetables during the last decade. Sensitivity Price Index (SPI inflation) was also taken into consideration to measure the price inflation of 52 essential commodities.

Identification of Isolation and Quarantine Facilities for COVID-19 Affectees in Sindh

To cater to the emergent COVID-19 situation in the province, the Wing was directed by the worthy Chairman P&D Board to conduct a situational analysis to identify Quarantine and Isolation facilities in all 29 districts of the province. The Wing prepared a structured proforma to capture relevant indicators associated with 'existing' and 'proposed' Quarantine, Isolation and Critical-Care facilities in all the districts.

The relevant data was collected from Divisional Commissioners and Deputy Commissioners to ascertain the existing situation of facilities and identification of proposed facilities for COVID-19 affectees in Sindh. The data and requisite information were compiled in a report format and shared with Honorable Chief Minister for further necessary action with regards to addressing deficiencies in existing facilities and acquiring proposed facilities.

As the cases began to increase significantly, another iteration of this exercise was conducted with a focus on existing and proposed isolation facilities. All districts, except the districts of Karachi, were directed to provide integrated services in one facility with augmented capacity rather than fragmented service delivery.

Research Report on 'Doing Business Reforms

Research Report on 'Doing Business Reforms: Creating a Conducive Regulatory Environment to Improve Manufacturing Competitiveness'

R&T Wing prepared and submitted a brief report with actionable evidence on 'Doing Business Reforms: Creating a Conducive Regulatory Environment to Improve Manufacturing Competitiveness' to the Honorable Chairman P&D Board with a holistic analysis of regulatory constraints faced by businesses, especially the manufacturing sector, in Sindh. The report drew from a diverse body of research to analyze the key challenges faced by businesses and manufacturing sector in Sindh, especially Karachi.

Short-term, Medium-Term and Long-Term action plans with corresponding roles of Government Departments were developed to address a wide range of thematic areas including starting a business, dealing with construction permits, property registration, enforcing contracts and paying taxes. Specific recommendations based on local and global evidence were provided to address the regulatory issues facing businesses and to create a conducive environment for improved competitiveness of the manufacturing sector.

Meeting with USAID-Pakistan Capacity Development Services for Digitalization

Director-General and Social Sector Advisor R&T Wing held a series of meetings with the Chief of Party of USAID's Pakistan Capacity Development Services for mutually beneficial collaborations.

The meaningful interactions with the USAID-PCDS Team culminated in a proposal for digitalization of Planning & Development Department. Social Sector Advisor developed the Terms of References for Digitalization after technical input from Director-General R&T Wing, Member (Development) P&D Board and Director-General Urban Policy & Strategic Planning. The finalized ToRs were shared with USAID-PCDS team to develop a concrete proposal for digitalization.

USAID-PCDS team presented the proposal for digitalization to Chairperson P&D Board and senior P&D Officials for feedback and further necessary action. Operationalization of digitalization was recommended to be undertaken by USAID-PCDS team.

R&T Wing worked under the guidance of Chief Economist (P&DD, Govt. of Sindh) to critically analyze the 'Working Paper of Annual Plan Coordination Committee 2020' to review the Annual Plan 2019-20 and Proposed Annual Plan 2020-21. Economic performance of FY 2019-20 was analyzed in terms of overall economic growth and sectoral trends.

Fiscal, monetary developments and other macro-economic indicators were also reviewed based on national estimates relative to estimations by international institutions. Economic Outlook for 2020-21 was also scrutinized based on the prevailing trends due to COVID-19 Pandemic and other relevant events (e.g. Locust Invasion). An analytical brief was prepared for the Honorable Chief Minister to serve as a frame of reference for discussions in the National Economic Council (NEC) meeting.

In discussions with World Bank Team's Health, Nutrition& Population Specialist, Health Economist and PPP-Consultant, DG R&T Wing stressed upon undertaking critical research to analyze the prevailing Public-Private Partnership contracts in health to move towards optimal solutions. World Bank's team agreed and worked with R&T Wing to conceptualize the Consultative Workshop to initiate discussions about the critical research with senior professionals from the government, development sector, academia and think tanks.

Consultative workshops have culminated into a prospective research study that will be undertaken by the Community Health Sciences of Agha Khan University. R&T Wing will continue its collaboration with the World Bank Team and Researchers for Technical inputs and feedback.

The institutional strength, readiness and responsiveness are truly revealed when a country is faced with an unforeseen shock or disaster.
