

## FOSTERING

EVIDENCE-BASED PLANNING WITH RESEARCH AND CAPACITY DEVELOPMENT

## Executive Summary

Formerly known as the Sindh Regional Planning Organization (SRPO), the Research and Training Wing was formed in 2006 after SRPO was repealed in 2005. The overarching idea of its formation was to act as an in-house capacity development body for the Planning and Development Department (Govt. of Sindh) and ultimately cater to the capacity needs of all the government departments. Unfortunately, the Wing remained dormant till 2017, after which the P&DD initiated its revitalization and restructuring with support from the European Union's Public Financial Management- Support for Pakistan Program team.

Under the leadership of Chairman P&D Board and guidance of the Secretary Planning and Chief Economist, the process of revitalization and restructuring began in 2017. The reorientation towards a technical organizations' setup entailed hiring sectoral experts from open market to develop the Wing and facilitate its evolution as a premier knowledge transmitting institute. A state-of-the-art office was also established to cater to the modern needs of the research personnel. With the completion of hiring process in early 2018, the Wing was equipped with the human capital to progress as a capacity development body for P&DD.

The Wing has been able to impart trainings and conduct actionable research to inform strategic planning of the Department. The Wing has quickly been able to develop a work-plan with P&D Board's approval and has already delved into operationalizing the objectives defined in its work-plan. During FY 2020-21, R&TW has been able to impart trainings on a broad spectrum of topics including report writing skills, evidence-based program design, effective presentation skills, PC-1 Appraisal & Evaluation Techniques and CERP's monitoring & evaluation boot camp. Partner academic institutions, like IBA-Karachi, tailored their trainings to the needs of P&DD officials.

Research & Training Wing has been at the forefront of research with actionable research conducted during FY 2020-21. R&T Wing has developed a 'Practical Guide for the Financial and Economic Appraisal of PC-I Proposals' for an overview of financial and economic analysis & appraisal of PC-I proposals with techniques and stylized examples for P&DD Sections and Line Departments.

In April 2020, R&T Wing developed a report on the estimated impact of COVID-19 on key provincial macro-economic and socio-economic indicators in order to identify prioritized areas of intervention for the Government to guide economic recovery and social protection of the vulnerable segments of population. The provincial estimations were computed using the national-level estimated sectoral impact by the Sub-Committee of National Coordination Committee tasked with COVID-19 economic analysis. During FY 2020-21, EU PFM-SPP Team for Sindh used this report as a frame of reference to develop a report on COVID-19: Macroeconomic & Social Impact and Framework for Development Response in Sindh'. The report was submitted to and approved by the Hon. Chief Minister Sindh for dissemination to priority departments for sector planning based on the proposed recommendations documented in the report.

R&T Wing has also developed a 'Knowledge Repository' as a centralized database of over 20,400 key policy, strategic, legislative and other salient documents that may be referred to by government officials, development practitioners, researchers and other relevant stakeholders for readily available information, especially important and non-trivial official documents. The Virtual Repository has gone live on the website with technical support from IS&T Department and will be regularly updated with key documents. The Wing is committed to the capacity building of our officers and utilizing quality research for evidence-based planning and policy formulation to cater to the needs of our population with a dynamic approach.

To foster partnerships for actionable research and capacity development, R&T Wing signed Memorandums of Understanding with Institute of Business Administration (IBA-Karachi) and Institute of Business Management (IoBM) during the CFY. It is hoped that these MoUs would translate into meaningful collaborations for improvement in public sector development and service delivery.

The ultimate aim of the Wing is to be a source of practical knowledge transmission by conducting research and imparting training through longterm partnerships with academia, development partners and other stakeholders. The Wing will keep evolving and developing with support from the Government leadership that initiated its revitalization.

## OUR JOURNEY

#### HISTORY

The Research and Training Wing was formerly known as Sindh Regional Planning Organization and was formed under SRPO Act of 1976. SRPO was responsible for developing district level plans for P&DD and inform the overall planning for the province. The structure of organization was different from what it is now, and the overall functions of SRPO were not specific and thus not focused. The SRPO was repealed in 2005 and Research and Training Wing was formed in 2006. The Wing was envisioned as the knowledge hub for P&DD for evidence-based planning and policy formulation using high-quality research.

#### REVITALIZATION

Despite its formation and organization in 2006, the Wing still lacked focus on the training and research functions, and thus the department remained virtually dormant. Therefore, in 2017, the Planning and Development Department of the Government of Sindh initiated the process of revitalization with technical support from European Union Public Financial Management Support Program for Pakistan (EU PFM-SPP). The primary aim was to enhance public sector delivery, to enhance the capacity of human resource and to meet the modern-day critical development challenges by adopting modern techniques and tools for sustainable development of Sindh.

## REFORM

The reforms undertaken for revitalization, restructuring and strengthening of the Wing were initiated by the senior leadership of GoS and P&DD, especially Hon. Chief Minister, Chairman P&D Board, Secretary Planning and Chief Economist (P&DD). Since the revitalization of the Wing in 2017, there has been a change in organizational structure and now the Wing works in a lean technical setup. Since the re-revised project proposal has been approved, a technical team of the core staff has been made to undertake capacity development and research initiatives.

## **Research** Approach

Research and Training Wing (R&TW) envisions creating an eco-system of stakeholders from academia, government and industry for dynamic inter-linkages that culminate into evidence-based planning and research-based policy making. R&TW aims to play the instrumental role of a conduit between the academia and government to bring together top international and national researchers to engage with policy makers in Sindh and Pakistan for effective solutions to the challenges faced by the province and country. Our approach is centered on actionable academic research that feeds into planning and policy formulation of the Planning and Development Department. Ultimately, our partnerships and collaborations with both academia and industry would lead to improved service delivery for the population. Capacity development of the public sector is also a core component of our objectives which has both direct and indirect inter-linkages with our research approach.

## Sindh District Profiles 2021

With the aim of creating a holistic snapshot of key institutional and household indicators of the province at granular level, the Research & Training Wing of the Planning & Development Department has created 'District Profiles' for Sindh that ranges over 1,000 pages in total. The overarching idea behind this endeavor is to create disaggregated socio-economic profiles for the districts to delineate a cross-sectional evidence-base that can be effectively utilized for multiple purposes by policy-makers, development practitioners, researchers and other relevant stakeholders.

District Profiles comprise of brief snippet of history & culture, population demographic indicators, Social Indicators (housing, utilities, health, education, multi-dimensional poverty) and Economic Indicators (Agriculture, Livestock & Fisheries, Manufacturing, Wealth Index).

District Profiles extract information from the credible official data sources including Population Census of 2017, Multiple Indicator Cluster Survey 2018-19, Development Statistics 2019, Sindh Education Profile 2019, and Health Profile 2017.

## Knowledge Repository

The Research & Training Wing has developed a centralized Knowledge Repository to address the information needs pertaining to various thematic areas of not only the Planning & Development Department but also the Line Departments, development practitioners, researchers and other relevant stakeholders for research, analysis and other functions.

The Wing was successful in populating more than 20,000 documents ranging from Legislations, Regulations, Policies and other relevant salient documents pertaining to all the Line Departments of Govt. of Sindh and Government of Pakistan (Federal). 'Knowledge Repository' is envisioned as a live database that is frequently upgraded to reflect updates in terms of legislations, rules, regulations, policies and other significant documents.

## Financial & Economic Appraisal of PC-1

The Research and Training Wing has developed a practical guide (Financial & Economic Appraisal of PC-1) with the over-riding aim to delve into the review of key concepts pertaining to financial and economic appraisals of project proposals.

The overarching objective of this Guide is to facilitate a paradigm shift from the focus on scrutinizing the internal consistency of the proposals or the sole emphasis on cost rationalization towards ascertaining quantifiable 'returns on investment' indicators associated with the proposed projects.

For evidence-based planning, it is essential to provide credible evidence to quantify and substantiate the potential impact associated with the proposed project. The quality of appraisal would generate a demand for the executing agencies to justify the need of the proposed project with sufficient and unequivocal evidence on the spectrum of potential benefits.















## **Systematic Review** of Global Health Response to COVID-19

From the onset of 2020, the world witnessed a highly contagious disease, known as Novel Corona Virus Disease 2019 i.e. "COVID-19" with a debilitating effect on everyone at individual and societal level. As the situation was evolving, the Wing delved into critical analysis of initial global health response and government's initiatives to combat the pandemic along with prescriptions to strengthen health systems to deal with epidemics in the future.

R&T Wing has developed an in-house research report on 'Systematic Review of Global Health Response to COVID-19 with a Strategic Focus on Pakistan & Sindh'. The report is centered on reviewing the global health response to tackle the COVID-19 pandemic, including that of Pakistan & Sindh, to propose prescriptions for health systems strengthening in Pakistan along six broad thematic areas (i.e. Service Delivery, Health Financing, Capacity Enhancement, Public Policy & Legislation, Governance & Leadership and Digital Transformation).





## **Sindh Rural** Enterprise Development

In the FY 2020-21, the Research & Training Wing has developed a working paper for the 'Rural Enterprise Development Strategy for Sindh' to provide a blueprint and strategic roadmap for enterprise development as an instrument to unlock the economic potential of the rural economy in Sindh.

The conceptual framework of 'Rural Enterprise Development Strategy' is centered on spurring entrepreneurial activities in rural areas by facilitating access to inputs, capacity building, product development and market-connectivity. The strategy must be viewed from the lens of a 'continuum' from community mobilization under PPRP to pursuing inclusive growth via Poverty Reduction Strategy. The primary objective of developing a concept note for 'Sindh Rural Enterprise Development Strategy' is to provide a strategic framework for revitalization of the rural economy of Sindh by harnessing social mobilization, capacity building and other income generating initiatives for empowering the rural communities with a 'whole of government' approach.





## COVID-19

Macro-economic & Social Impact and Framework for Development Response in Sindh

Previously, Research & Training Wing developed a brief report to estimate the macroeconomic & social impact of COVID-19 in Sindh along with a development response framework in April, 2020. At that point, the situation was uncertain and evolving with time.

After the fiscal year 2019-20 ended, P&D Department engaged the team of European Union-Public Financial Management Support Program for Pakistan in Sindh to develop a comprehensive report that details the macroeconomic & social impact of COVID-19 in Sindh along with actionable recommendations for the Government to undertake strategic short-term and medium- to long-term actions to mitigate the impact. Under the guidance of Chief Economist, Research & Training Wing worked with EU PFM Advisor, and his team to develop the report along with the action matrix mapped against corresponding departments. The report was approved by Honorable Chief Minister Sindh and the soft copy was shared with priority departments accordingly for sectoral planning.




#### **Report Writing Skills** For Development Projects

The Research & Training Wing partnered with Akhtar Hameed Khan National Centre for Rural Development (AHKNCRD) housed in the Establishment Division of the Government of Pakistan in a three-day online training for developing report writing skills pertaining to public sector development projects.

The training was centered on effective research and analytical writing skills. Research Associates, Monitoring, Evaluation & Learning Officer and Procurement Officer from R&T Wing participated in the three-day training on 'Report Writing Skills for Development Projects'.

Participants learned how to strengthen their skill of observing, analyzing, evaluating and drafting qualitative and quantitative research reports backed by credible evidence. The rigorous training imparted valuable reporting skills that are critical to effective written communication in the public sector.

## **Evidence Based** Programme Design

Research and Training Wing collaborated with Center for Economic Research in Pakistan (CERP) virtually to ensure participation from the Government of Sindh in CERP's training keeping in view the COVID-19 SOPs. The programme taught participants to apply Smart Policy Design and Implementation (SPDI): a six-step framework identified by EPoD that integrates evidence to develop policies. The eminent faculty included professors like Dr. Malik Ammar from Harvard University, Asim Ijaz Khwaja - Harvard University, Professor Tahir Andrabi - Visiting Scholar from Massachusetts Institute of Technology, Maha Rehman and Dr. Farah Said from Lahore University of Management Sciences.

The four-day rigorous program covered thematic areas pertaining to theory of change, cost-benefit analysis, sampling design, and program evaluation methods. The program focused on how to apply a structured and highly practical approach to programme design and implementation, incorporating theory and evidence to maximize effectiveness.





## **Effective** Presentation Skills

R&T Wing collaborated with Pakistan Institute of Management for a two-day training on 'Effective Presentation Skills' that was attended by P&D Officers. The focus was on articulating and presenting ideas with confidence at relevant forums. The overarching focus was on presenting a range of ideas to a diverse group of audience in a coherent manner.

Strategic communication plans were devised based on the interactions with the participants for a streamlined plan of action to strengthen effective presentation and communication abilities. The immersive training program also required the trainees to practically present to the audience to inculcate confidence that translates into improved communication and presentation skills.





## **PC-1 Appraisal** & Evaluation Techniques

Research and Training Wing collaborated with the Institute of Business Administration (IBA-Karachi) for a rigorous and comprehensive training to impart practical knowledge and skills pertaining to the appraisal and analysis of the all the facets of PC-I Project Proposal. Focus of this program and each session was on the 'reading comprehension', 'critical thinking' and 'critical analysis' of PC-I proposals shared by executing agencies/line departments.

The training focused on comprehending, analyzing, filtering and refining technical proposals in a way that can be presented to the senior P&DD officials (e.g. Chief Economist, Members of the Board, Sec. Planning, Chairman P&D Board) to take effective decisions, based on the quality of information provided. The overarching aim was to solidify the foundations of the Decision Support System (DSS) by effectively strengthening and improving the analytical skills of the Planning Officers and Assistant Chiefs.

#### Monitoring & Evaluation Boot Camp

Research and Training Wing collaborated with Center for Economic Research in Pakistan (CERP) to ensure participation from the Government of Sindh's Planning & Development Department in CERP's virtual training on 'Monitoring & Evaluation'. The training program was taught by leading M&E specialists and global experts, with the aim to strengthen participants' technical skills pertaining to monitoring and evaluation, qualitative and quantitative research methodologies, and project management.

The monitoring and evaluation skills, that are essential to professionals working in the development sector, were imparted during the training to enhance the capacity to effectively monitor and evaluate projects and programmes. The fourday rigorous training was attended by Officers from P&DD technical sections, Monitoring & Evaluation Cell, and the Research & Training Wing.

#### **COVID-19 Impact in Sindh**

Macro-Economic and Social Impact and Framework for Development Response

After the fiscal year 2019-20 ended, P&D Department engaged the team of European Union-Public Financial Management Support Program for Pakistan in Sindh to develop a comprehensive report that details the macroeconomic & social impact of COVID-19 in Sindh along with actionable recommendations for the Government to undertake strategic short-term and medium- to long-term actions to mitigate the impact.

Dr. Vaqar Ahmed, EU PFM Advisor, and his team developed the report along with the action matrix mapped against corresponding departments. The salient points of this report were presented to the relevant departments on 8<sup>th</sup> December, 2020. The main task of this report was to develop an improved understanding of the medium-term macroeconomic and social impact of the pandemic along with implications for the fiscal performance. Subsequently, feedback from priority departments was utilized to provide concrete short- and medium- to long-term recommendations. The report was submitted to and approved by the Honorable Chief Minister Sindh for dissemination to the priority departments.





#### **Social Policy &** Community Building in The Age of Digitalization

Research & Training Wing collaborated with Nanyang Technological University of Singapore to organize a multi-country webinar on 'Social Policies and Community Building in the Age of Digitalisation – Post Covid-19 Norm'. Senior Government Officials from Indonesia, Singapore, Philippines and Thailand to discuss how governments could leverage digital platforms and collaborate with civil society organisations, businesses, social entrepreneurs in designing and implementing social policies and public services to rebuild the community in the new normal. Chief Economist presented on Pakistan's evolution of poverty reduction and social protection efforts and Sindh-specific poverty reduction strategy and its implications in Post COVID-19 context.





#### Pakistan Competitive Cities Index

Based on the directives of the Chairman P&D Board, R&T Wing worked under the guidance of Special Secretary with regards to the data collection from relevant agencies for computations of Hyderabad city vis-à-vis World Bank's 'Pakistan Competitive Cities Index (PCCI)'. The specific indicators included public-private dialogue, own-source revenue, construction permits, water supply, solid waste management, and vocational training.

R&T Wing coordinated with the World Bank team and relevant government agencies for provision of the required data for PCCI computation for Hyderabad city. Data was collected from Sindh Building Control Authority, STEVTA, Local Government Department, Commissioner Office, Hyderabad Development Authority, Hyderabad Municipal Corporation, and Hyderabad Water & Sanitation Agency. Following the data consolidation and competitive cities index computation, a virtual capacity-building workshop was conducted on 31st March, 2021 for all the relevant stakeholders, including R&T Wing.





#### Strengthening Sindh Bureau of Statistics

In February 2021, Ernst & Young Ford Rhodes (EYFR) team, engaged by Economic Reforms Unit of the Finance Department, submitted the consolidated report titled "Final Consolidated Recommendation Report" to P&DD for review and perusal with regards to meaningful reforms for revitalization and restructuring of SBoS. EYFR report was reviewed from various standpoints by the designated P&D committee, including capacitating human capital and organizational restructuring of SBoS through a comprehensive HR assessment. For this purpose, Special Secretary, P&DD proposed to bring Research & Training Wing, P&DD onboard in order to review the EYFR report in context of organizational restructuring and HR assessment of the current SBoS employees at a granular level.

In light of EYFR report, section wise competencies were designed by R&T Wing with the objective of gauging the current job nature and competencies of employees. R&T Wing interviewed 37 SBoS Employees (BS-17 & above) at the head-office to carry out Human Resources Assessment of SBoS in order to ascertain the competencies of current employees in order to provide a micro-level analysis of the current state of the organization relative to desired state that is hoped to be achieved via revitalization and restructuring. The interim report with recommendations was submitted to Special Secretary P&DD.

#### MoU Signing Between IBA and R&T Wing

In the presence of Chief Economist, the Wing entered into a partnership with the Institute of Business Administration (IBA). The MoU was signed between the Secretary (Planning – P&DD) and Director (Center for Executive Education-IBA Karachi). MoU has been signed to foster partnerships in the field of actionable research and capacity development. The MoU will also enable collaboration to design customized training programs for P&DD Officials with the aim of adopting modern approaches to public sector development planning.

Research and Training Wing has already signed MoUs with SZABIST and NEDUET in the past to formalize partnerships with academia. R&TW has undertaken this endeavor of MoUs with academia in the context of Government of Sindh's strong willingness to create an eco-system for meaningful collaboration with academia that permeate across different sectors to contribute to knowledge diffusion and capacity development in order to find innovative solutions to the development challenges facing the province.

#### MoU Signing Between IoBM and R&T Wing


